WIMBLEDON TICKET ANNOUNCEMENT 2011

ROYAL NAVY LAWN TENNIS ASSOCIATION (RNLTA) – TICKETS FOR THE WIMBLEDON CHAMPIONSHIPS 2011

1. The Wimbledon Championships will be held from Monday 20 June to Sunday 3 July 2011.
2. The expected allocation of tickets to RNLTA members in 2011 is:

Centre Court	10 seats each day
No. 1 Court	14 seats each day
No. 2 Court	2 seats each day for the first 9 days.

4. All serving personnel are members of the RNLTA and therefore entitled to apply for tickets. All retired officers, ratings and other ranks of the RN and RM who have registered as an RNLTA Associate Member also qualify: however, those recently retired personnel who wish to enrol may do so at a one-off cost of £25. Tickets will be allocated by ballot to personnel still serving on 20 June 2011 and Associate Members, priority being given to RNLTA committee members and players who represented the RN in any of the 2010 fixtures. Applicants successful in the ballot will be allocated a pair of adjacent seats for one day of The Championships; tickets will not be sold singly.
5. When making an application, either the form reproduced below should be used, or you may apply by letter which must contain the following information:
- First, second, third and fourth choice of day; two of these days must be in the first week.
 - Whether seats are required for Centre, No.1 or No.2 Court.
 - Whether seats for another day or court are acceptable if choices cannot be met.
 - Confirmation that the applicant will be serving on 20 June 2011 or is an Associate Member of the RNLTA.
6. Tickets allocated must on no account be resold or transferred other than to the person accompanying the applicant to and at The Championships. The names of all members allocated tickets are reported to the Lawn Tennis Association and should proof be forthcoming that this rule has been broken then this may result in the future allocation to the RNLTA being reduced or withheld.
7. Full details of the **CONDITIONS OF SALE** and the **RAINCHECK POLICY** will be issued to all successful applicants.

8. Applications for tickets must reach the **Secretary RNLTA, HMS TEMERAIRE, Burnaby Road, Portsmouth, Hants PO1 2HB** no later than **Friday 8 April 2011** **ENCLOSING A STAMPED & ADDRESSED ENVELOPE FOR REPLY. MONEY MUST NOT BE SENT WITH APPLICATIONS.**
9. Applications for Associate Membership of the RNLTA should be forwarded to the same address enclosing a cheque for £25 made payable to the 'RNLTA'.
10. All applicants will be informed whether or not they have been successful in the ballot. Successful applicants will be required to pay for their tickets before these are issued. Tickets will be issued during the week commencing Monday 23 May 2011 or on receipt of payment whichever is later. Any tickets not paid for by Friday 3 June 2011 may be re-allocated without further notice.
